

I-16: Parent Permission for Participation in a Student Club



Board Policy I-16 allows authorized student clubs to meet on school premises during non-instructional time. Student clubs are student initiated and led. Meetings must not be sponsored or endorsed in any way by the school, district, or board.

A designated faculty supervisor is to be present at the meetings and activities of student clubs held at the school. Faculty monitors provide oversight to ensure compliance with the club's approved charter, constitution, and by-laws and with applicable laws, rules, and policy. Faculty monitors do not participate in or direct the club meetings and activities.

The school does not monitor or regulate the meetings or activities of a student club held at a location other than a scheduled meeting at the school. The students are solely responsible for their activities and safety at any meetings or activities held at times or locations other than scheduled school meetings.
