

# **Parental/Guardian Permission and Waiver Agreement**

## **Consent for medical treatment**

As the parent or legal guardian of the above-named player, I hereby give my consent for emergency medical care prescribed by a duly licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are deemed necessary to preserve the life, limb, or well-being of the registrant.

## **Participation Risk Statement**

I, the undersigned, am a parent or legal guardian of the above-named minor. I fully understand that participating in the sport of tackle football presents a risk for serious injury or death. In my capacity as parent or legal guardian, I understand the risks and my responsibility to notify the other parent or legal guardians as well as the minor of the risks involved with sport participation. I am not aware that the named minor has any medical condition that would prevent the named minor from fully participating in tackle football or that would increase the risk of injury or incident to the named minor. I believe that the named minor is physically fit to participate in tackle football and agree that it is my responsibility to ensure that the named minor is physically fit to participate in tackle football. I have made a conscious decision to allow the named minor to play. I agree that my health and accident insurance will be the primary insurance to cover expenses for any injury, including rehabilitation. I do hereby waive, release, and agree to hold harmless the coaches, organizers, sponsors, supervisors, referees, employees and participants of Utah Girls Tackle Football League from any claim arising out of any injury to the named minor whether the result of negligence or for any other cause.

## **Equipment Responsibility**

I agree to assume full responsibility for any and all equipment/uniforms loaned to the named minor and I agree to promptly return the equipment at the conclusion of the season in good condition, except for normal wear and tear. I agree to pay the full replacement cost of the equipment if I fail to return it.

## **Promotional Consent**

I hereby consent, as a condition of my child's participation, to receive communications via email from Utah Girls Tackle Football League and its partners. I hereby grant Utah Girls Tackle Football League and its partners the absolute right

and permission to make, reproduce, broadcast or otherwise use the named minor's name and likeness, any photograph, films, videos, recordings, or other depictions or images in whatever form or media in connection with participation in tackle football in any and all advertising and promotion materials, in any manner or media whatsoever for purposes of art, advertising, editorial, trade or promotion or any other purpose whatsoever. To the extent that any benefit accrues or may accrue to Utah Girls Tackle Football League or its partners, I hereby and forever waive any interest in or claim to such benefits and acknowledge that Utah Girls Tackle Football League is under no obligation to exercise any rights granted herein.

### **Code of Personal Conduct**

I agree to conduct myself in a respectful, courteous, and sportsmanlike manner at all times. Any person who, at a practice or game, is using alcohol, tobacco or non-prescription drugs and/or appears to be intoxicated or who is rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects or uses profane language will be asked to leave the event and may be banned from attending other events.
